The trials are free and open to footballers who live within 90 minutes travel time of the training facility (or 60 minutes traveling time for the age groups Under 7 – Under 15's) and will consist of small-sided games in each individual age group (number dependent). The Academy coaching and recruitment team will be on hand to watch each group in a safe, pressure free environment. However **you must be pre-registered** to attend the trials and have parental consent.

## **ARRIVAL AND REGISTRATION**

On arrival please report to the appointed designated meeting place: The front reception at Boots and Laces, where players will be registered and shown to an appropriate changing area.

Unfortunately there is insufficient parking at Boots and Laces and parents / guardians are therefore requested to find alternative parking either at Waitrose or in the car park at Jones Memorial.

Refreshments for parents will be available at Boots and Laces and a designated parent's area will be marked out on the training ground for parents wanting to spectate. **Please note that due to unforeseen circumstances these arrangements may be changed at late notice, in which case you will be advised of the new arrangements upon arrival.**

FROM M25 – TAKE JUNCTION 29 – A127 TO SOUTHEND (APPROX 40 MINS)

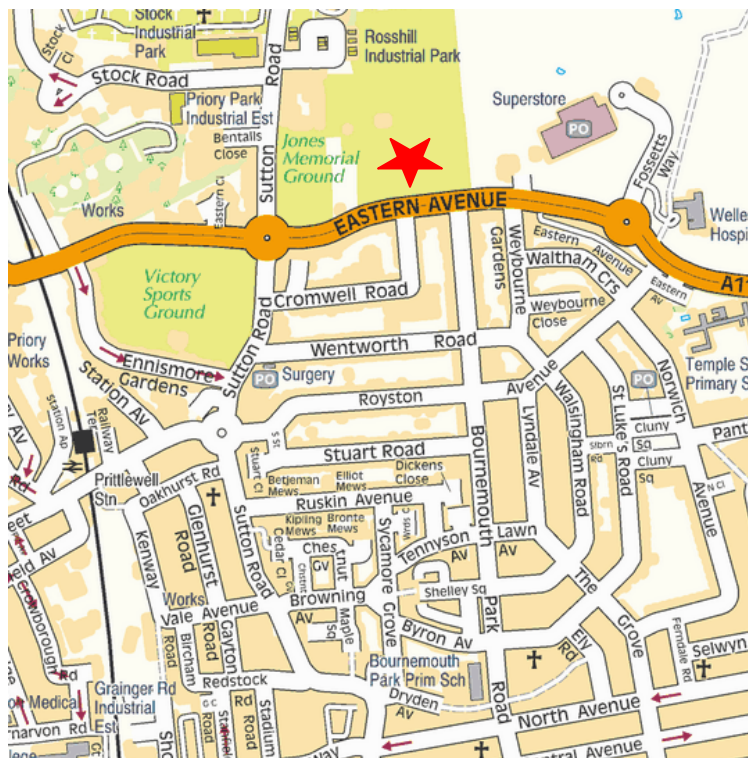
FROM A12 – TAKE A130 TURN OFF- SOUTHEND  
TURN OFF AT A127 (APPROX 30 MINS)

ABOUT 2 MILES OUTSIDE TOWN CENTRE (PAST TESCO ROUNDABOUT) MAJOR SET OF TRAFFIC LIGHTS WITH THE TOBY / BELL PUB ON THE LEFT – GO STRAIGHT ON

500 YDS FURTHER ON – ROUNDABOUT – TAKE 2<sup>ND</sup> EXIT (STRAIGHT OVER) TOWARDS SHOEBURYNNESS (A1159)

FOLLOW ROAD ROUND PARK PAST CAR CENTRE ON LEFT, CONTINUE UP THE HILL AND OVER THE RAILWAY BRIDGE TO NEXT ROUNDABOUT – TAKE 2<sup>ND</sup> EXIT (STRAIGHT OVER)

THE TRAINING GROUND IS APPROX 500 YDS ON THE LEFT (NEXT DOOR TO AND JUST BEFORE WAITROSE SUPERMARKET).
